4. Strategic Decisions

4.1 <u>Drainage</u>

- Caro will be working with Mark Scrimshaw to move forward with MOE on what they will be covering and have more information next meeting.

4.2 <u>Fundraising / School Donations</u>

Decision: The Board agreed that school fees will be raised by \$50 per year over the next 2 years. This will take the school fees to the following:

Family free (2 children or more): 2024 \$270 & 2025 \$320

Individual Student Family: 2024 \$180 & 2025 \$230

The Board has noted:

• there would be the option to pay in full at the beginning of the year OR term payments.

4.3 <u>Confirmation of Mid term election</u>

4.4 <u>Fundraising Resolutions</u>

- The Mākara Model School Board resolved that a request be made to each of the following organisations for funding for the amount of \$30,000 to replace the concrete netball court: Pelorus Trust, Grassroots Trust Central, Pub Charity, Lion Foundation, and Trusts Community Foundation
- The Mākara Model School Board resolved that a request be made to the Meridian Energy West Wind fund for the amount of \$70,000 to replace the concrete netball court

5.1 <u>Health & Safety</u>

5.2 Principals Report

The Board thanked Caro for the report and noted:

- Kahui Ako would like to invite Boards to a Board breakfast on 18th Oct. Venue to be advised.
- Bathroom renovation has moved to the next phase. Current completion date 31st January 2024.
- Quotes for the court have come back at around \$80 000 plus \$1500 for marking.
- Breakfast Club is only breaking even, so will be re-evaluated for 2024.
