- 4. Strategic Decisions

# 4.1 <u>Court Update</u>

• Fundraising - we had to return \$10 000 that we had received for the Court as we had to wait so long for funding.

- We have raised \$28 000 from MoE / \$15 000 from NZCT / \$20 000 from Meridian. This is a total of \$63 000 towards the court expense. This leaves between \$10K and \$15K more to commit to the project.
- The project will need to be started soon or we risk losing the MoE funds and potentially others
- The Board agrees to pay the extra finances required to cover the cost of the court.

# • Decision: The Board agreed that the school will commit up to \$15000 to the court project. - Moved by Ali Kirkpatrick / Seconded by Andrew Graham

# 4.2 <u>Mid Term Elections</u>

- NZSTA has confirmed that the board is in a position to co-opt board members as we only have 4 parents representatives.
- To co-opt the board will need to fill out an eligibility form that will need to lodged and approved before we can begin the process.

# 4.3 <u>Fundraising / School Donations</u>

• The Mākara Model School Board resolved that a request be made to the Four Winds Foundation for the amount of \$10,000 to replace the concrete netball court.

# 5.1 <u>Health & Safety</u>

The Board noted that there are no health and safety incidents to report. The Hazard Register is a standing item at staff meetings and hazards are quickly addressed.

# 5.2 Principals Report

The Board thanked Caro for the report and noted:

- The school currently sits at 90 tamariki with stable attendance (apart from illnesses) and will start 2024 with 83 / 84 tamariki.
- These role numbers mean that in 2024 the 4th teacher and CRT teacher is covered by MoE funding.
- Teachers will be changing to different class levels in 2024.
- Renovation still on track to finish mid January.
- School fee increase discussed at the last board meeting was not in line with other schools around Wellington. The increase will be updated and sent out to the community between November 13th and 17th.

Decision: The Board agreed that school fees will be raised in 2024 and then again in 2025. This will take the school fees to the following: 2024 - 1 Child \$190 / 2 Children \$290 / 3+ Children \$310 2025 - 1 Child \$240 / 2 Children \$360 / 3+ Children \$400
